What's New in 2013

- It is no longer legal to hunt wolves at night during any part of the wolf hunting season. See pages 5-7 for hunting hour restrictions.

Harvest License Issuance

Resident License: \$49; Non-resident License: \$251

- A wolf harvest license including the valid, unused wolf pelt tag are required to be in your possession while hunting or trapping wolf.
- Once selected to receive a wolf harvest license, you must purchase a wolf harvest license prior to hunting or trapping wolf.
- **Applicants who are successful in the random or preference drawing, or who fail to apply for either a preference point or a license at least once during any three consecutive years will lose all previously accumulated preference points.**
- Applicants who do not want to be entered for the license drawing in a particular year may choose to apply for a preference point. There is no minimum age restriction to apply for a preference point. A person must be at least age 10 before they may purchase a wolf harvest license unless they only intend to trap wolf AND have completed trapper education.
- Members of the U.S. Armed Forces or National Guard who are selected for a license through the cumulative preference system and are unable to hunt or trap wolves during this license year because of active duty service can choose to receive a preference point in lieu of the license.

Hunter and Trapper Education Requirements

- Persons born on or after Jan. 1, 1973 who **intend to hunt** wolf with a firearm, bow, or crossbow must present their Hunter Education certificate or proof of successful completion of basic training in the U.S. Armed Forces, Reserves, or National Guard to purchase a wolf harvest license unless participating in the Hunting Mentorship program. Visit dnr.wi.gov; keywords: 'mentored hunting' for more information.
- Persons who **intend to trap** wolf must successfully complete a Wisconsin Trapper Education course or other approved trapper education course unless exempt from this requirement; see the *Trapping Regulations* for exemptions.

Transfer of License and Preference Points

- Wolf harvest licenses may be transferred to a youth or adult who is eligible to use the license, provided the transfer application is received by 15 days prior to the start of the season.
- Preference points may be transferred to a youth upon the death of the preference point holder. Call the DNR Call Center (1-888-936-7463) for more information.
- A resident who chooses to transfer their wolf harvest license to a non-resident must pay the difference in license fees at the time of the transfer application.
- A person transferring their license to another person may not be paid or receive any other consideration for the transfer of the license.

Hunting and Trapping Season Information

Season Dates: Oct. 15, 2013 - Feb. 28, 2014

The DNR may close a wolf harvesting zone to both wolf hunting and trapping if the season quota in a particular zone is likely to be reached prior to the end of the season or if closures is deemed necessary for biological reasons. If early closure of a wolf zone is necessary, it will take effect 24 hours after the DNR has:

- 1) posted notice of the closure at dnr.wi.gov;
- 2) announced the closure on the telephone reporting system (1-855-299-9653); and
- 3) issued a press release announcing the closure.

NOTE: It is the hunter or trapper's responsibility to determine the closure status of a wolf zone prior to attempting to hunt or trap wolf in that zone. If you are unsure, call the telephone reporting system listed above or contact the DNR call center at 1-888-936-7463.

It is illegal to hunt wolves outside the CWD zone with a firearm on Nov. 22. A firearm may be uncased, loaded, and used to kill a lawfully trapped wolf at the trap site statewide on Nov. 22.

Zones: In 2013, wolves may be pursued statewide* except for zones that are closed early to effectively manage the wolf population in that zone.

* Wolf harvest licenses and tags are not valid and may not be used within the exterior boundaries of the Bad River, Lac Courte Oreilles, Lac du Flambeau, Menominee, and Red Cliff reservations nor within the designated Stockbridge-Munsee wolf zone except with DNR depredation permits.

Blaze Orange Clothing: Blaze orange clothing requirements apply when hunting wolves whenever there is also a season open for hunting deer with firearms. See the 2013 *Deer Regulations* for season dates.

Hunting in State Parks: For information about hunting in state parks, see the 2013 *Small Game Regulations* or dnr.wi.gov; keywords ‘hunting state parks’.

Hunting and Trapping on the St. Croix Riverway: Hunting is allowed according to Wisconsin state regulations with a few exceptions in the St. Croix National Scenic Riverway. For more information, please visit www.nps.gov/sacn/planyourvisit/hunting.htm.

Trapping is restricted in the St. Croix National Scenic Riverway. For more information, please visit www.nps.gov/sacn/planyourvisit/trapping.htm. The National Park Service has specific regulations on these sites to inform the public of special Federal regulations already in place.

Methods for Hunting

A wolf harvest license and carcass tag authorizes hunting of wolf by any of the following methods:

- 1) An authorized firearm, bow and arrow, or crossbow.
- 2) With the use of dogs to track or trail wolf from Dec. 2, 2013 - last day of season.
- 3) Predator calls, including electronic calls.
- 4) Bait that does not contain animal parts, animal by-products other than liquid scents, or substances poisonous to canines. See below for additional restrictions on baiting.

See pages 4-9 of the *Small Game Regulations* for additional hunting, firearm, bow, and crossbow restrictions that apply to hunting of all species.

Firearms and crossbows authorized for wolf hunting include:

- centerfire rifles .22 caliber or larger.
- muzzleloaders that are discharged from the shoulder **and** fire shot larger than size BB **or** fire a single ball or projectile at least .45 caliber if smoothbore or .40 caliber if the barrel is rifled.
- black powder handguns which are .44 caliber or larger, have a minimum barrel length of seven inches, and fire a single projectile weighing 138 grains or larger.
- handguns with a minimum barrel length of 5½ inches and loaded with centerfire cartridges of .22 caliber or larger.
- shotguns larger than .410 that fire slugs or shotshells loaded with shot larger than size BB.
- crossbows must have a minimum 100 pound draw weight, a working safety, and use bolts or arrows of not less than 14 inches in length with a broadhead.

Dogs: Hunting wolves with dogs is legal from Dec. 2, 2013 - last day of season. *It is illegal to:*

- train dogs to pursue wolf.
- hunt or pursue wolves with dogs unless the person using the dogs has on their person rabies tags and license tags for each dog.
- hunt or pursue wolves with a dog that is not tattooed or that isn’t wearing a collar with the owner’s name and address attached.
- allow a dog to kill any wild animal. The use of firearms, crossbows, and bow and arrow are the only legal hunting methods allowed to kill a wolf.
- use more than six dogs in a single pack to trail or track wolf, regardless of the number of people assisting the holder of the wolf harvest license or the dog’s ownership.
- hunt wolves with dogs outside of the hunting hours listed on pages 6-7.

Night Hunting: It is NOT legal to hunt wolves outside of the hours listed on pages 6 and 7.

Telemetry Devices: *It is illegal to use radio-telemetry or similar equipment to locate, pursue, or hunt any wolf that has been fitted with a radio transmitter.* **NOTE:** It is legal to possess a radio-telemetry receiver if pursuing a wolf with dogs that are equipped with radio transmitters and the device is only used for locating transmitters attached to the dogs.

Bait: Bait or feed may be placed and used for the purpose of hunting wolves except *it is illegal to place, use, or hunt over bait or feed for wolves:*

- from Mar. 1 - Oct. 8, 2013 and from Mar. 1 - Oct. 7, 2014.
- in excess of 10 gallons.
- that is not totally enclosed in a hollow log, a hole in the ground, or stump which is capped with logs, rocks, or other naturally occurring and unprocessed substances which prevent deer from accessing the material. Liquid scent does not need to be enclosed, but is part of the 10 gallon limit.
- unless, when the bait site is checked or re-baited, all bait that has been uncovered is again enclosed and made inaccessible to deer.
- unless the person placing the bait possesses a valid wolf harvest license or written authorization from the holder of a valid wolf harvest license to place and maintain a bait site for the licensee. Written authorization must include:
 - 1) name, address, and phone number of the licensee;
 - 2) name, address, and phone number of the person placing or maintaining the bait site; and
 - 3) the county, town, and property owner's name for the location where the licensee has authorized assistance with the bait site.
- containing any animal part, animal by-product other than liquid scent, or substances that are poisonous to canines.

NOTE: Wolves may be hunted over bait or feed lawfully placed for hunting bear or training bear dogs when bear hunting season was open, or for hunting deer as long as the wolf season is open and the bait site does not contain any material that is poisonous to canines.

Methods for Trapping

Traps: *It is illegal to set, place, or operate steel-jawed foothold traps with a maximum jaw spread width of more than 7 inches from Oct. 15 - Nov. 30 on dry land, or any foothold trap larger than 8 inches from Dec. 1, 2013 - Feb. 28, 2014.* See pages 8-12 of the *Trapping Regulations* for additional trap type, size, and placement restrictions that apply to trapping of all species.

Cable Restraints: *It is illegal to set, place, or operate any cable restraint for wolves except from Dec. 1, 2013 - Feb 28, 2014.* To be a legal set, the cable restraint must:

- be 10 feet or less in length with a diameter of 3/32 inch or larger and be composed of multiple strands of galvanized aircraft cable wire;
- have cable stops that ensure that the portion of the cable which makes up the noose loop may not be longer than 48 inches when fully open or less than eight inches when fully closed;
- be set with the bottom of the cable loop six to 14 inches above the surface, where the surface is soil, ice, crusted or packed snow, or any other hard surface;
- include a reverse-bend washer lock with a minimum outside diameter of 1¼ inches and a 1,500 pound roller (or barrel) swivel that acts as the maximum opening cable stop; and
- be staked in a manner that does not allow the restraint device to reach any part of a fence, rooted woody vegetation greater than ½ inch in diameter, or any other immovable object or stake that could cause entanglement.

Dispatch Methods: A wolf caught in a trap may only be killed with a firearm. Alternative methods for dispatch are illegal. Age and mentoring or accompanying requirements apply to the use of a firearm; for more information, visit dnr.wi.gov; keywords: 'mentored hunting'. While not a legal firearm for shooting a wolf while hunting, a licensed wolf trapper may use a .22 caliber rimfire cartridge to kill a wolf lawfully caught in a trap. A person who has legally trapped a wolf but is prohibited from possessing a firearm may authorize a companion who can

legally possess a firearm to kill the trapped wolf humanely with a firearm.

Incidental Take: It is legal to retain any raccoon, coyote, fox, or bobcat taken incidentally with a cable restraint **IF** it is the open season for hunting or trapping the animal, **AND** the trapper has the necessary unfilled license, permits, and tags for that species.

Tagging and Registration

Upon killing a wolf, the harvester must do all of the following:

- 1) immediately validate and attach the **PELT** tag to the wolf in the manner described on the tag. After skinning the wolf, the **CARCASS** tag shall be attached to the skinned carcass, and the **PELT** tag shall be left attached to the pelt.
- 2) notify the DNR within 24 hours of harvesting the wolf by calling 1-855-299-9653 between 7 A.M. and 10 P.M.;
- 3) exhibit the pelt and 'skinned-out' carcass for registration with an authorized DNR representative no later than five days after the month of harvest. Please call your local conservation warden or service center to determine available times for registration; **AND**
- 4) surrender the skinned out carcass or any part of the carcass required by the department for population monitoring*.

* Persons who intend to have the wolf mounted by a taxidermist may exhibit the wolf to the department for registration without separating the pelt. The skinned carcass must be surrendered to the department within 30 days of registration.

It is illegal to:

- possess a wolf carcass or pelt longer than five days after the month of harvest without registering the pelt with an authorized DNR representative.
- possess, control, store, or transport a wolf carcass unless it is tagged as required. The removal of a pelt tag from a wolf prior to registration results in the wolf being untagged, and illegal to possess.
- transfer, give, trade, sell, or purchase a raw pelt or unskinned carcass of a wolf without a registration tag attached and locked to the pelt.
- remove the pelt and registration tag prior to its removal by a fur dresser or taxidermist at the time of preparation.

NOTE: A person who harvests a wolf that has an attached or implanted radio telemetry device **MUST RETURN** the device to the DNR. If requested by the harvester, the DNR will share any data collected about that wolf.

Attacks on Domestic Animals

On private lands, the landowner, lessee, or occupant of the land, or any other person with permission of the landowner, lessee, or occupant may shoot and kill any wolf in the act of killing, wounding, or biting a domestic animal. Shootings shall be reported to a department conservation warden within 24 hours. The wolf carcass must be surrendered to the department.

Hunting and Trapping Hours

It is **NOT** legal to hunt wolves outside of the hunting hours listed on pages 6 and 7. 'Hunt' or 'hunting' includes shooting, shooting at, pursuing, taking, capturing, or killing, or attempting to capture or kill any wild animal.

Trapping Hours are from 4 A.M. to 8 P.M. and normal trap check periods apply. See page 8 of the *Trapping Regulations* for more information.







NOTE CONCERNING FORT MCCOY: Access is by special permit only. Wolf harvesting will not be allowed during the 2013-14 season. Contact 608-388-3337 for more information.
